President's Message

August 2000

This issue of the *Utah Libraries News*, the first ever published in electronic format, represents a milestone for ULA. I am pleased and honored that my first opportunity to address the membership corresponds with this hallmark in ULA's communication history.

Much has transpired since ULA was founded in 1912. In that year, for example, the U.S. Congress passed the Radio Act to begin regulating the fledgling broadcasting industry, a harbinger of modern debates over the use of Internet filters. Legislation of this type had little bearing on the library profession in 1912, as electronic communication did not affect reading or the ways in which text and image appeared on the published page.

Clearly, the implications for librarianship have changed dramatically in the ensuing 88 years, with communication now unquestionably THE issue of the day – regardless of the medium. At the June 16th Board Meeting (following the wonderful Ogden 2000 conference – with many thanks to all who helped make that event so memorable!), Melanie Hawks, Staff Development Officer, University of Utah's Marriott Library, facilitated a training session to help the Board identify ways in which we might focus our potential. Through large and small group discussions it became clear that our Board members believe ULA is most successful at creating opportunities for people to network and remain informed about professional issues, but lacks the ability to communicate effectively with our membership.

I see this as the single, most important issue this organization has to work on, and intend to make it the locus of my presidency. Many creative souls are already involved in improving the organization's ability to talk to itself, both through the electronic publication of *Utah Libraries News* and by developing an electronic bulletin board. With most libraries in the State now linked to the Internet, we foresee these tools increasing the ease and timeliness with which we can connect the membership to issues of importance to librarians, while decreasing costs associated with traditional print media. Of course, as a preservation librarian, I will also see that steps are taken to ensure a clear "paper trail" is left for the sake of future.

But communication is a two-way exchange. We need to keep working on the process of "opening into each other" as Webster so eloquently put it. Please get involved and help us develop during this exciting period, as ULA is only a reflection of the cumulative thoughts and feelings of its members.

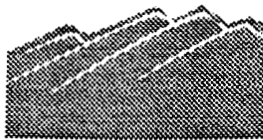
